IMPORTANT NOTICE TO ALL DISTRICT RESIDENTS

HAZARDOUS WASTE DISPOSAL

THE TOWN OF HEMPSTEAD PROHIBITS THE DISPOSAL OF HAZARDOUS MATERIALS AT ANY OF ITS FACILITIES. THEY PROVIDE SPECIAL COLLECTION DAYS WHEN TOWN RESIDENTS MAY BRING HAZARDOUS HOUSEHOLD WASTES TO A DESIGNATED SITE. YOU CAN CALL THE TOWN OF HEMPSTEAD AT 378-2200 FOR AVAILABLE DATES AND SITES.

SOME ITEMS THAT ARE RECONSIDERED TO BE HAZARDOUS AND NOT PERMITTED TO BE PUT OUT FOR COLLECTION:

ANTIFREEZE, AMMONIA, ASBESTOS, BLEACH, BUG AND RODENT KILLERS, CHEMISTRY SETS, DEGREASER, DISINFECTANTS, DRAIN CLEANERS, FERTILIZERS, HERBICIDES, FLAMMABLE LIQUIDS, KEROSENE, LAQUER, LATEX AND OIL BASED PAINTS, OVEN CLEANERS, PAINT STRIPPER AND THINNERS, PHOTOGRAPHY CHEMICALS, WOOD PRESERVATIVES, SOLVENTS, SPOT REMOVERS, SWIMMING POOL CHEMICALS, VARNISH, WEED KILLERS, PESTICIDES, ETC.

THE ITEMS LISTED ABOVE MAY BE TAKEN TO THE "STOP" PROGRAM SPONSORED BY THE TOWN OF HEMPSTEAD. CHECK FOR AVAILABLE DATE AND SITE BY CALLING 378-2200.

THESE ITEMS LISTED AND ANY OTHER HAZARDOUS MATERIALS MAY NOT BE BROUGHT TO OR DROPPED OFF AT THE DISTRICT PREMISES.

ANY PERSON DROPPING OFF MATERIALS DEEMED TO BE HAZARDOUS, IS IN SERIOUS VIOLATION OF FEDERAL, STATE, COUNTY AND TOWN ENVIROMENTAL LAWS AND WILL BE PROSECUTED TO THE FULLEST EXTENT OF THE LAW.
